Sovereign BBQs advises that it is not appropriate to have persons operating your BBQ who are not familiar with its operational procedure (the correct operational procedure is outlined in the "Installation and Operating Instructions").

Sovereign BBQs further advises that children should be supervised at all times whilst in the vicinity of your BBQ (your BBQ will become hot when cooking), and at no time operate the BBQ without the presence of a competent adult familiar with the correct operational procedure of your Sovereign BBQ.

While all Sovereign BBQs are designed to withstand the harsh conditions of the outdoor environment, protective measures can be put in place to prevent reasonable wear and tear. Sovereign BBQs advises that the purchaser read and adhere to the "cleaning and maintenance" section of the enclosed "Installation and Operating Instructions", and ensure that all mechanical parts of the BBQ are confirmed to be operating normally prior to using your BBQ on each and every occasion. Should you at any stage be concerned, please contact a qualified gas technician immediately.

This warranty and disclosure does not limit a consumers right of action under the Trade Practices Act (CTH) 1974 or any other Australian consumer legislation.



## WARRANTY

This warranty is valid for a period of one year (12 months) from the date of purchase.

The following items should have been included with your new Sovereign BBQ.

1. Installation and Operating Instructions;
2. Disclaimer;
3. This Warranty;
4. Warranty Registration Card.

Should any of the above documentation have not been received, please contact Sovereign BBQs or download any of the above documents from the Sovereign BBQs website. It is of the utmost importance, to both your safety and the validity of your warranty, that you receive and read **all** of the above documentation.

During the warranty period your Sovereign BBQ is warranted against defects or default in manufacture. Sovereign BBQs will carry our repairs under warranty pursuant to the following:

1. An original invoice or proof of purchase documentation is provided.
2. The owner is responsible for transportation and insurance costs associated with any repairs.

The warranty is VOID under the following circumstances:

1. The BBQ has not been used in accordance with the Sovereign BBQs "Installation and Operating Instructions", and that failure to operate the BBQ in accordance with these instructions has caused the subsequent damage.
2. Where the BBQ has been clearly misused, abused or neglected; and as such the basis of the warranty claim is not for the repair of a defect. This includes damage caused by dropping.
3. Damage caused by the negligence of the purchaser, operator or other third party.
